AMENDMENT

In Rule 5, 22(1)(i), (ii), 27, 28, 44(3) and 45(2) of the said rules the words and figures 9.5% per annum shall be substituted by the words and figures 8.5% per annum. The amendment in Rule 5 will come into effect from 1.4.2003 onwards, amendment in other rules will come into effect from the date of issuing of this notification.

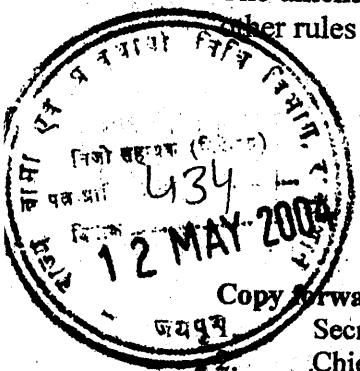


