Terms and conditions:

- 1. The Large Ear Tags for large bovines (cows and buffaloes) in entire Rajasthan (Districts wise) as per requirement which will be shared latter.
- 2. The estimated quantity mentioned above is tentative and it may increase or decrease as per requirement.
- 3. The rate offered by the bidder shall not exceed Rs. 6.80/- + GST and including all other expenses likely to be incurred in supply for per large ear tag including tag applicator. Each box of 2000 large ear tags shall contain one tag applicator with two extra pins. Each compatible universal applicator should be capable of ear tagging at least two thousand large animals.
- 4. The technical specifications of large ear tags and tag applicators shall be ensured as per Annexure-1 of DO Letter dated 17.03.2022, issued by DAHD, Gol.
- 5. The bidder shall get tested the quality of ear tags at CIPET Laboratories as per directions mentioned in point number 06 of the DO Letter dated 17.03.2022 before giving supply to the State Insurance & Provident Fund Department. The successful bidder shall make available Large Ear Tags, for large Bovines (cows and buffaloes) required for sampling before complete supply of the order. Sampling for the quality testing from designated labs i.e., CIPET Labs will be done as per the DO Letter Dated 17-03-2022 by the Department as per the sampling plan mentioned in the letter of 17-03-2022 Annexure-V. At the time of the supply in-house test report to be given by the bidder. The payment will be released only after the receipt of the quality testing from the designated CIPET labs. The cost of all the testing will be borne by the supplier.
- 6. Department will place the purchase order to the L1 bidder after issuance of Letter of Acceptance (LOA) and the successful bidder shall supply quantity mentioned in purchase order for each destination within 15 days after issuing of the purchase order. Purchase order will be sent to L1 bidder/successful bidder electronically through E-mail and a copy of purchase order may be sent physically. Date of issuance of PO will be considered for calculation of supply period.

18. Jurisdiction & dispute resolution: -

This procurement is being governed by laws of India and shall subject to exclusive jurisdiction of court of Jaipur (Rajasthan) only. Legal proceeding if any, arising out of the Bid shall have to be lodged in courts situated in Jaipur City only.

19 Delayed Supply, extension of supply period& recoveries etc: -

As department is expecting early and timely supply of the Large Ear Tags, for large Bovines (cows and buffaloes), it is expected that supplies shall be made available with in stipulated supply period and schedule as mentioned in point number 06. But if case arises regarding delayed supplies, bidder shall represent the matter to the Additional Director, General Insurance Fund (SIPF), Jaipur in writing before 2 days of expiry of supply period mentioned in Purchase Order as per supply schedule mentioned at point number 06 of bid document. GIF (SIPF) may or may not extend the supply period depending on the conditions and need of the department. Extension of supply period/delivery period shall be granted with Liquidated Damages (LD), mentioned below:-

In case of extension of supply period or delivery period with liquidated damages the recovery shall be made based on following percentage of value of the stores which the bidder has failed to supply:-

Dear Sir Madam.

As you are aware, identification of livestock by ear tagging with 12-digit unique ID is compulsory. Accordingly, ear tags for large and small animals, including pigs, have already been distributed to States/UTs through NAFED (PLA). However, in view of additional demand for ear tags from States / UTs, States/UTs may procure them directly from the ear tag subject to the SOP prepared by the Department, which is as under -

- State/UT concerned shall submit its proposal for additional number of large ear tags with proper justification (consolidated requirement arising under NADCP, NAIP, etc.) to DAHD.
 The technical specifications for large animal ear tags is enclosed (Ann I).
- After receiving approval from DAHD, states/UTs shall place the order for the approved quantity of large ear tags with the ear tag manufactures / suppliers who have already supplied them under NADCP (Ref. Ann II).
- The specification of the large ear tags and tag applicators should remain as those supplied till date under NADCP through PLA (NAFED)
- States/UTs should place order for procurement of additional large ear tags (as per existing specifications) at the approved rate, i.e., not exceeding Rs. 6.80 + GST per large ear tag, including tag applicator (Compatible Universal applicator with 2 extra pins should be supplied, which should be capable of ear tagging at least 2000 large/small animal).
- After placing orders, States/UTs should connect with NDDB representative(s) concerned(ref Ann III) for providing serial numbers and bar codes which shall then be provided to the selected manufacturer(s) for printing on the large ear tags
- Before taking supply, State/UT shall test quality of ear tags at CIPET laboratories (details in Ann IV). Sampling to be done by States /UTs as was done under NADCP (ref Ann V). QC testing to Copy of quotation of CIPET for testing of samples is also enclosed (Ann VI).
- Funds will be reimbursed by the Department, if necessary, after providing copy of the receipts/invoices of large ear tags, test results and other details related to QC including receipts. However, no funds will be provided for TA and DA, logistics etc.

You are requested to direct your officers concerned to strictly adhere to the SOP for procurement of large ear tags under NADCP henceforth.



Technical specification for Tag applicator

The applicator and its pin should be reliable for mass Tagging and should be supplied by ear Tags suppliers for ear Tag. The pin should be reliable for a minimum of 2,000 ear Tag applications. Undertaking for the same shall be given by the bidder/supplier.

- The applicator should be branded with the manufacturer's name /logo engraved on the metal portion on the upper applicator's jaw.
- 2. A spare pin should be supplied along with each applicator and located in the applicator's handle.
- 3. The applicator weight should not exceed 300 grams+-10%.
- 4. The applicator should be made of high-quality die cast aluminum.
- 5. The applicator should have an inbuilt metal locker located in the articulation jaw only.
- The ear Tag applicator should be compatible for the application of visual ear Tags.
- Each ear Tag applicator should be packaged individually into a good quality plastic bag along with a colored notice/instruction to use of ear Tag application in English.


